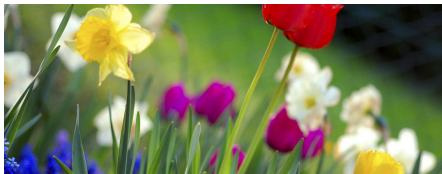
Additionally please email APlus and the board; fines may be issued.
